French aristocrat Alexis de Tocqueville was 26 years old when he came to America in 1831. He was a keen observer of American society. Based on his findings, he wrote *Democracy in America*, which was published in two volumes in 1835 and 1840. Central to de Tocqueville's writings was his admiration for the American spirit of voluntary actions for the common good. He recognized, applauded, and immortalized the voluntary spirit that energized the lives of Americans.

The Alexis de Tocqueville society was created to honor that good will and community leadership that inspired de Tocqueville's writings 185 years ago. Nationally, the Tocqueville Society was established by United Way Worldwide in 1984 as a movement to celebrate and recognize individuals investing in their community with gifts of \$10,000 and more.

Since 1996, United Way of Greater Stark County's Alexis de Tocqueville Society members have been at the vanguard of improving the lives of countless individuals and families through extraordinary financial gifts, volunteerism, and advocacy. For many, being a member is an opportunity to have a hands-on role in solving the challenges affecting greater Stark County to create a better future for us all.

United Way of Greater Stark County Tocqueville Society members join a national network of 420 Alexis de Tocqueville Societies and more than 25,000 philanthropic leaders in a movement that is committed to creating opportunities for everyone in our community. **Locally, there are 81 members, 18 of them new in 2019. Born in Canton to fathers who emigrated from Italy in 1920, Fred and Virginia Olivieri were well known in their high schools. "Personality, football queen and talented" were words describing Virginia. "Freddie" was the "life of the party." Not much has changed since those days, as Fred and Virginia put their personalities and talents together to make a dynamic impact in the community in which they grew up and have loved.

Together they founded the Fred Olivieri Construction Company in December of 1959 – sixty years ago - in the basement of their 21st Street NW home. What started as a home building business, quickly turned into commercial contracting when the company landed its first commercial job – an addition to a church in McDonaldsville, Ohio.

Their skills complement each other, and they are the perfect match. Married 67 years, they have always been a team. Their children, Christine and Dean said, "Both our parents worked. Mom ran the office, paid the bills and typed up a storm. She was the vice-president of the company. Dad was the president and did everything from estimating jobs to working in the field."

The hallmark of their business has always been growth and innovation which led them into areas they never imagined back in their basement office days. In the 1960's, during the boom of a "gas station on every corner" era, they built 125 gas stations. The 1970's brought them McDonald's and to date they have built or remodeled 500. In the 1980's Fred and Virginia passed on the presidency of Fred Olivieri Construction Company to their

son Dean who, through Fred and Virginia's mentorship, has continued the vision and innovation of his parents.

"Philanthropy has always been important to our parents," say Chris and Dean. "They say 'modeling is the best way to teach children.' Mom and Dad showed us by doing. It was simply instilled in us to give back from a young age." They have been life-long members of St. Michael's Catholic Church which has nurtured the enduring faith that has guided them throughout their lives. Their desire to put their faith into action has led them to be very generous to the causes they have loved in their community including Walsh University, Aultman Hospital, Mercy Medical Center, and The American Heart Association. Members of United Way of Greater Stark County's Alexis de Tocqueville Society for nearly 25 years, they have passed that spirit of giving and making a difference in their community on to their family and entire company.

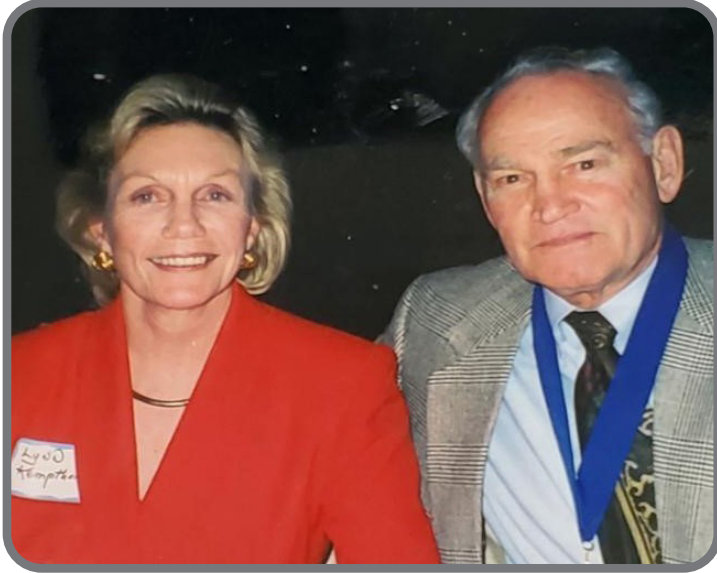
"Although our parents are hardworking, that is only one aspect of them. We were taught, again by example, that family comes first. They were at every band concert, football game, play and baseball game. Every night there were family dinners as well as family vacations every summer," say their kids. They continue that philosophy with their six granddaughters – Dean and Grace's girls: Sarah and Tony Johnson, Emily Olivieri, and Rachel and David Doria, as well as Christine's daughters – Taylor and Andy Johnson, Dana and Andrew Bilinovich, and Paige Hackett. Coming up to learn from their great grandparents are

four great grandchildren. Sarah and Tony's children – Nathan, Ava, and Elliott as well as Rachel and David's son, Dean. Fred and Virginia have been blessed by their family, but we the children, grandchildren, and great grandchildren have enjoyed the gift of unconditional love and true mentorship from Fred and Virginia Olivieri.



DICK AND LYNN KEMPTHORN

“DO UNTO OTHERS...”



Richard and Marilynn Kempthorn were lifelong residents of Canton Ohio, settling on a farm in Jackson Township after their marriage in 1956. Never ones for the spotlight, they raised their family surrounded by the quiet setting of rolling hills and noisy barnyards. Dick was the only child of James and Lucille Kempthorn and was taught early about the benefit of hard work by his father James, the founder of Kempthorn Motors. Lynn was born in California to Colonel Howard and Alvena Couch and like most military brats, traveled the country as her father was moved from city to city as a military commander. Colonel Howard Couch was killed while flying the ‘Hump’ in WWII, an event that forever changed Lynn’s idyllic childhood.

Dick Kempthorn was a fixture of the Canton community starting with his heroic efforts on the Canton McKinley Bulldogs football team beginning in 1942. After high school Dick was admitted to the Merchant Marine Academy and served on the crew of the ship USS Wild Hunter, which participated in the invasion of the Philippines. After World War II he went to the University of Michigan, where he was described as “the roughest young man we’ve had around here.” He was a star player on the undefeated national championship teams in 1947 and 1948 and was the most valuable player on the team in 1949.

The Korean conflict broke out soon after graduation from Michigan and he chose to serve his country again, this time in the United States Air Force as a fighter pilot. Dick flew more than 100 missions and earned the Distinguished Flying Cross for bravery for pulling a fellow serviceman out of a burning aircraft. Upon

returning from the war Dick could have named his own price and played for any team he wanted in the NFL but chose instead to return to Canton and join his father’s Dodge-Chrysler Auto dealership. He bought the dealership from his Father in 1964 and went on to develop one of the largest auto malls in northeast Ohio comprising of 10 auto franchises at one location. Until his passing in February 2019, he reported to work at 1449 Cleveland Ave nearly every day.

Lynn was the silent strong type giving of her time freely to civic causes and working in schools as a speech therapist. The farm was her first love and she raised their three children, Jim, Dana, and Eric to appreciate hard work and the simple life. Lynn was always at Dick’s side with support and she was the backbone of the family, keeping the “trains running on time.” Having had three children within 4½ years, the hectic schedules of school athletics and a farm full of animals needing attention was not a job for the faint of heart. Eric recalls, “Dad never walked in the door from a day of work without finding his beloved ‘Lynn’ and planting a kiss on her.” As the kids recalled, “She was his world during those crazy busy years, and he showed us by example how great marriages work.”

Richard and Marilynn taught the family that “to whom much is given, much is expected” and they didn’t just say it but lived it. They gave generously to hundreds of causes but near and dear to their hearts were the United Way of Greater Stark County, YMCA, and their beloved church family, Bethel Temple Assembly of God. Revered by his employees as a leader, coach and counselor, he lived by the bible verse, “Do unto others as you would have done unto you.” The legacy that Dick and Lynn left their family and company is one of setting goals, persevering, and caring for family and their community.

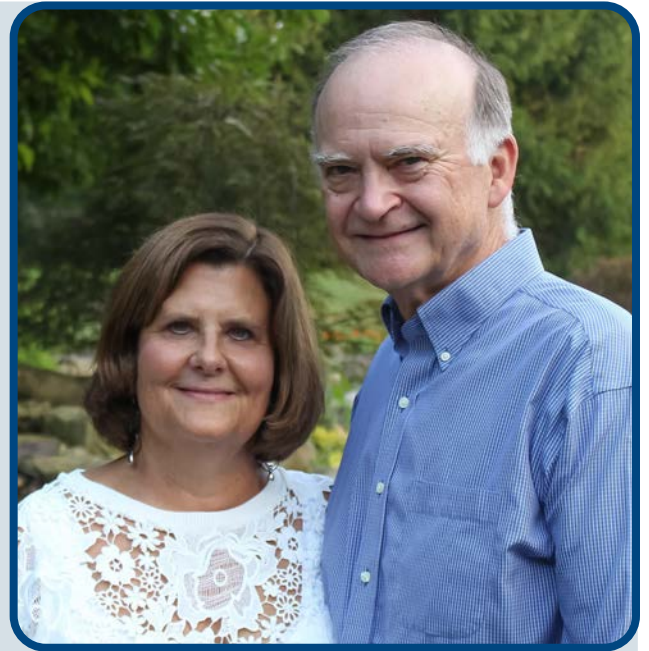
Women United brings life to our vision of “creating opportunities for supporting the emotional and intellectual growth of women and young children, with a focus on moving families out of poverty” by initiatives such as:

- **Advocacy** in the area of Family-Friendly Workplaces. We understand that employment can be a path out of poverty, but the transition may be complicated. Work and family responsibilities are inextricably linked for most employees.
- **Mentoring** through Canton City Schools Girl UP program. This program introduces girls in grades 7 through 10 to explore nontraditional career paths. Nontraditional careers are defined for women, as those in which 25% or less of those employed in the field are women. Salaries in nontraditional careers can be 20% to 30% higher than those for traditional careers.

“By volunteering through Women United, I’m able to utilize my professional talents to help other women move out of poverty to a more financially stable life. As a donor, I support United Way because they look at what services and programs can have systemic change in our community. While the need to address emergency assistance is important, we must address the underlying issues that cause the continuing emergency needs.”

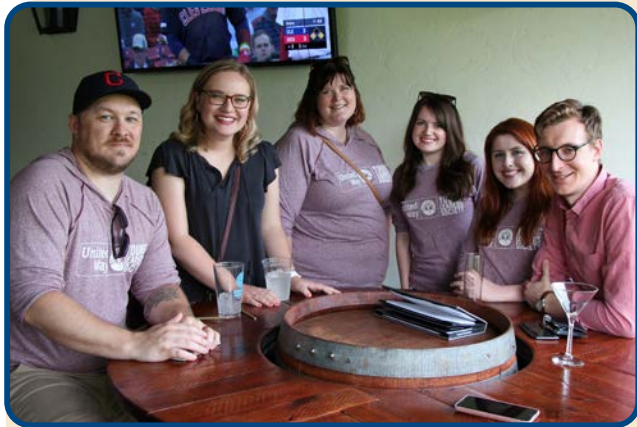
