During the fall of 1832, Alexis de Tocqueville, a young Frenchman, traveled nearly 8,000 miles across America speaking with individuals about the "great experiment" in democracy.

The spirit of selflessness and cooperation among Americans amazed de Tocqueville. His written work, *Democracy in America*, reflects his admiration for the American spirit of voluntary action for the common good.

Founded in 1981 by Thomas F. Frist, Jr., the Tocqueville Society echoes the American spirit of cooperation and good will which he witnessed in early America. It personifies the true meaning of philanthropy, with members giving \$10,000 or more annually.

The Alexis de Tocqueville Society of United Way of Greater Stark County is one of the 420 local Tocqueville Societies in the U.S.

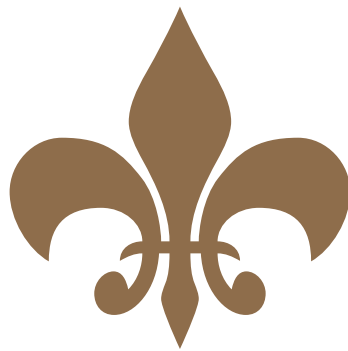

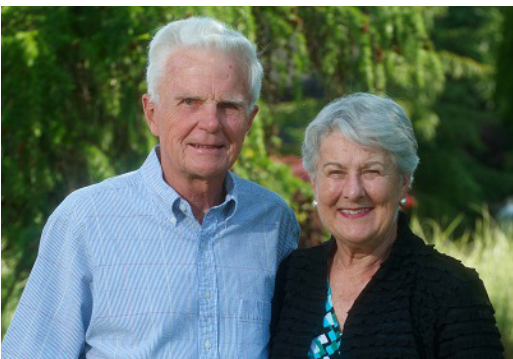

Just three years ago, I never would have thought my son could go to a regular high school and do well. I never thought he could do a lot of things on his own. He spent years struggling with schoolwork, feeling frustrated and stupid. He felt so badly about himself that he struggled to make friends, talk to girls or stick up for himself at all.

A lot has changed since then. He is a senior now and will be graduating from high school on June 2, with a 3.5 GPA. This year he earned his academic letter and will be attending Hocking College in August, majoring in Parks and Museum Education. He is really excited about this new opportunity.

I still can't believe he will be graduating in just a few weeks. I remember sitting and crying when he was in 1st grade. I knew he had dyslexia and couldn't get anyone to listen to me. I didn't even think he would graduate from high school.

And then we learned about the Canton Center for Dyslexia. After graduating from the Dyslexia Center my dreams for Seth went from hoping that he would graduate from high school to getting him into college. Now I can't wait to see all he accomplishes at college.

Because of all the time and effort they poured into him, Seth learned to be his own advocate. He is not

afraid to stand up for himself or to make sure the teachers give him the accommodations he needs. He has learned to organize his time and has done amazing in school and is really enjoying his life now.

He even started to run track and cross country and earned his Varsity Letter and the "most improved" award. His favorite subject is English. English!! Who would have ever guessed that? He also enjoys writing in his free time. He has written 3 science fiction books. He is constantly editing them and enlists the help of his friends to edit them as well. He would love to eventually become a published author.

I know his success would not be possible without the amazing tutoring he received at the Canton Dyslexia Center. We will be forever grateful for all you and the Dyslexia Center did for him.

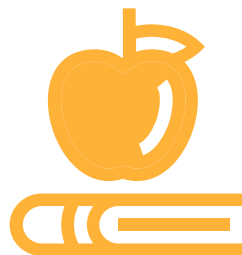
